





#### **Respite Care Services Policy Update**

- The DDA updated the Respite Care Services policy to remove barriers for people who choose to receive respite from someone who lives with them but is not the primary caregiver:
  - Respite is short-term care intended to give families or other caregivers and the person receiving services a break from their daily routines and caregiving responsibilities.
  - An individual who lives with the person may provide paid respite services as long as they are not the individual who normally provides care for the person.







## **Self-Directed Services (SDS)**





### **LTSS Transition**

- 50% "all-in" as of September 1, 2023
- 65% "all-in" by January 2024
- All providers have chosen a go-live date

#### **EVV Respite Reminder**

Under the DDA's Traditional Service Model, effective October 1, 2023:

- **Respite Care 15-minute** services will become a service billed through **EVV.**
- Respite Care daily services and camp are not required for EVV.



#### FY2022 and FY2023 Financial Statements Reminder Cost Detail Tool



#### **Audited Financial Statements**

- Required for Providers billing in LTSS*Maryland*.
- Needed for FY2022 and FY2023, and annually moving forward.
  - Due no later than (NLT) December 31, 2023, and annually following the close of the fiscal year NLT December 31 of the respective year. (FY2024 audited financial statements are due December 31, 2024.)
